

## The Council of Australian Governments (COAG)

April 2013

The next COAG meeting will be held in Canberra on Friday 19 April 2013. While a formal agenda for this meeting has not been released, key issues likely to be discussed include:

- The National Disability Insurance Scheme (NDIS) Details of NDIS legislation are still to be negotiated. At its last meeting COAG agreed to continue discussions on legislation with a report back to COAG in early 2013 on the outcome of these discussions. - National Plan for School Improvement On Saturday 14 April 2013 the Prime Minister released the proposed funding model to support the National Plan for School Improvement. More information on the Plan is available in Hawker Britton's Occasional Paper, <u>here.</u>
- **3.** Environmental Regulation Reform The Business Advisory Forum is to table their report to COAG on the outcomes of their work to streamline environmental regulation. A copy of the draft Framework is available <u>here.</u>
- **4. Review of GST Distribution** Treasurers have been asked to consider the Report of the GST Distribution Review with a report back to COAG in 2013. More information on the GST Distribution Review is available <u>here</u>.
- 5. Electricity Market Reform As part of COAG energy market reform agenda the Standing Council on Energy and Resources has been asked to advise COAG on the challenges facing the domestic gas market. # **COAG - Overview**

The Council of Australian Governments (COAG) is the peak intergovernmental forum in Australia. COAG comprises the Prime Minister, State Premiers, Territory Chief Ministers and

the President of the Australian Local Government Association (ALGA). The Prime Minister chairs COAG.

The role of COAG is to initiate, develop and monitor the implementation of policy reforms that are of national significance and which require cooperative action by Australian governments (for example, health, education and training, Indigenous reform, early childhood development, housing, microeconomic reform, climate change and energy, water reform and natural disaster arrangements).

Potential COAG issues may emerge from major initiatives of one government which impact on other governments or that require the cooperation of other governments. Other issues come to COAG from Ministerial Councils. This can be in the course of implementing existing policy, for example, National Competition Policy, or in developing policies such as food regulation reform.

COAG meets on an as-needed-basis and has met 34 times since it was established in 1992. The most recent meeting was held in December 2012.

Whereas the agenda for the COAG meeting usually is not available publicly prior to the meeting, the outcomes of COAG meetings are contained in communiqués released after each meeting. Where formal agreements are reached, these may be embodied in Intergovernmental Agreements.

### COAG Reform Council

The Reform Council has been established by COAG as part of the arrangements for federal financial relations to assist COAG in driving its reform agenda. Independent of individual governments, the Reform Council reports directly to COAG on reforms of national significance that require cooperative action by Australian governments.

In February 2011, COAG adopted a reform agenda built around five themes of strategic importance which all fall into the intersection of jurisdictional responsibilities. The five themes are:



- 1. A long term strategy for economic and social participation
- 2. A national economy driven by our competitive advantages
- 3. A more sustainable and liveable Australia
- 4. Better health services and a more sustainable health system for all Australians
- 5. Closing the Gap on Indigenous disadvantage.

The COAG reform agenda is implemented through National Agreements, National Partnerships, Water Management Partnerships under the Agreement on Murray-Darling Basin Reform, and other intergovernmental agreements.

On 4 December 2012 the COAG Reform Council released its third report on the progression of COAG's reform agenda. The report found that out of the 30 key reform commitments, three reforms have already been completed, 11 are on track and another 13 are likely to be completed although they might exceed their deadlines.

These reforms include early childhood education, standards for literacy and numeracy, improvements to teacher quality, a uniform national consumer law, a harmonised construction code, national regulations for vocational education, the Murray-Darling Basin plan and investment in remote indigenous housing.

However, the also report found that three major reforms are at risk of not being achieved at all. These are the workplace safety reform, directors' liability reform and the competition reforms in the energy sector.

### COAG Business Advisory Forum

On March 6 2012 Prime Minister Julia Gillard announced the establishment of the COAG Business Advisory Forum. The establishment of the Forum is part of the Government's broader deregulation agenda, and will complement existing work being undertaken by COAG's Business Regulation and Competition Reform Working Group. The inaugural meeting of the COAG Business Advisory Forum was held prior to the COAG meeting in April 2012.

The Council is due to meet Thursday 18 April 2013, the day before the COAG meeting and it is expected that energy market reform, carbon reduction and energy efficiency measures will be on the agenda.
